(The final name is subject to the approval of the relevant industrial and commercial registration authority.) An agreement has been signed with Suzhou Industrial Park Suxiang Cooperation Zone ("Suxiang Cooperation Zone") in February 2021.

With a total area of 50.58 km2, it is located in the northern part of Suzhou, adjacent to Suzhou North Station of the Beijing—Shanghai High-Speed Railway. Major current projects introduced to the Zone, with large-scale investment and high industrial levels, include AVIC, CASIC, Midea, Ping An, and Fuyao Group.
